A "foreign bank" does not include any foreign central bank or monetary authority that functions as a central bank, or any international financial institution or regional development bank formed by treaty or international agreement.

B. Correspondent Accounts Covered by this Certification:

This Certification applies to all accounts established for **E.SUN Bank entities** by Covered Financial Institutions.

C. Physical Presence/Regulated Affiliate Status:

Each of the **E.SUN Bank entities** maintains a **physical presence** in any country. That means that each of the E.SUN Bank Entities listed in the attachment hereto:

- Has a place of business at the street address set forth in the attachment hereto, where
 it employs one or more individuals on a full-time basis and maintains
 operating records related to this banking activities;
- Is authorized to conduct banking activities in the country where its place of business is located;
- Is subject to inspection by the Banking Authority identified in the attachment hereto that licensed the particular entity to conduct banking activities.

D. Indirect Use of Correspondent Accounts:

No Correspondent Account maintained by a Covered Financial Institution may be used to indirectly provide banking services to certain foreign banks. **E.SUN Bank entities** hereby certifies that it does **not** use any Correspondent Account with a Covered Financial Institution to indirectly provide banking services to any foreign bank that does not maintain a physical presence in any country and that is not a regulated affiliate.

E. Ownership Information:

E.SUN Financial Holding Company Ltd., located at 14F, No.117 & 1F, No.115, Sec.3, Minsheng E. Rd., Songshan District, Taipei, Taiwan, is a 100% direct owner of the E.SUN Bank entities. For purposes of this Certification, owner means any person who, directly or indirectly, (a) owns, controls, or has power to vote 25 percent or more of any class of voting securities or other voting interests of Foreign Bank; or (b) controls in any manner the election of a majority of the directors (or individuals exercising similar functions) of Foreign Bank. For purposes of this Certification, (i) person means any individual, bank, corporation, partnership, limited liability company or any other legal entity; (ii) voting securities or other voting interests means securities or other interests that entitle the holder to vote for or select directors (or individuals exercising similar functions); and (iii) members of the same family² shall be considered one person.

The same family means parents, spouses, children, siblings, uncles, aunts, grandparents, grandchildren, first cousins, stepchildren, stepsiblings, parents-in-law and spouses of any of the foregoing. In determining the ownership interests of the same family, any voting interest of any family member shall be taken into account.

F. Process Agent: complete the following.

E.SUN Commercial Bank, Ltd. Los Angeles Branch is a resident of the United States at the following address: 17700 Castleton street, Suite 500, City of Industry, CA 91748 USA, and is authorized to accept service of legal process on behalf of E.SUN Bank entities from the Secretary of the Treasury or the Attorney General of the United States pursuant to Section 5318(k) of title 31, United States Code.

G. General

E.SUN Bank entities hereby agrees to update this Certification published on the website whenever there is any change in facts or circumstances reported in this Certification. Given the signature date in this Certification, the Covered Financial institution can accurately examine when it is updated. The update will be completed within 30 calendar days of such change.

E.SUN Bank entities understands that each Covered Financial Institution at which it maintains a Correspondent Account may provide a copy of this Certification to the Secretary of the Treasury and the Attorney General of the United States. **E.SUN Bank entities** further understand that the statements contained in this Certification may be transmitted to one or more departments or agencies of the United States of America for the purpose of fulfilling such departments' and agencies' governmental functions.
